



Section 3 – External Auditor Report and Certificate 2019/20

In respect of **Upper Clatford Parish Council – HA0265**

1 Respective responsibilities of the body and the auditor

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

The Internal Auditor's response to Objective 1 is not consistent with the information in Section 1, Assertion 4 and the prior year external auditor report. The Internal Auditor has confirmed no evidence has been obtained regarding the public rights period provided for during 2019/20.
